**Tariff of Fees, Payments and Sums**  
**Recommended for approval and to become effective as from 1<sup>st</sup> April 2014**

Table of fees, payments and sums under Article 12 of the Local Authorities  
Cemeteries Order 1974 approved by King's Sutton Parish Council on 5<sup>th</sup> December  
2013, effective as from 1<sup>st</sup> April 2014.

The fees, payments and sums set out below apply:

1. Where the person to be interred, or in respect of whom the right is granted is,  
or immediately before his or her death, was an inhabitant or parishioner of the  
Parish of King's Sutton  
or
2. In the case of a still born child, where one of the parents is, at the time of the  
interment, such an inhabitant or parishioner.  
or
3. Where the interment is to be a grave previously purchased by the inhabitant or  
parishioner.

**In all other cases**, the fees, payments and sums will be doubled, except that those set  
out in Part 1 shall not be doubled *where the exclusive right of burial was previously  
acquired*.

**PART 1. INTERMENT OF BODIES - in plots other than in the Garden of  
Remembrance**

The fees indicated do not include the cost of digging the grave.

For the interment in any grave of bodies or cremated remains (*other than in the  
Garden of Remembrance*):

**PART 2. EXCLUSIVE RIGHTS OF BURIAL IN EARTHEN GRAVES:**

The fees indicated refer to the burial of bodies and cremated remains in plots  
(*including those in the Garden of Remembrance*)

For the exclusive right of burial for a period of up to 50 years in an earthen grave not  
exceeding 8 feet x 4 feet:

**PART 3. HEADSTONES AND MONUMENTAL INSCRIPTIONS:**

For the right to erect or place a plain headstone  
*(various designs and shapes shall be permitted, of a size within the dimensions below, but shall be of a long lasting material of stone or durably similar)*  
- not exceeding 3 feet in height and 2 feet in breadth  
- with a base below ground level not exceeding 4 feet x 1 foot 6 inches  
*(only on plots where exclusive right of burial has been granted)* **£70.00**

**PART 4. GARDEN OF REMEMBRANCE:**

a) For the right to lay flat a memorial stone  
- up to 18 inches x 18 inches x 2 inches for 50 years  
(flat surface to be laid level with ground) **£58.50**

b) For burial of cremated remains  
*(on plots where exclusive rights have been granted)* **£58.50**

**PART 5. JUBILEE ROSE GARDEN –**

**For the right to place a plaque to include plaque and rose**  
**£98.00**
